## TERMS AND CONDITIONS GENERAL

The 'Take a Chance on Greece' Lottery presented by Collette and CAA Atlantic (hereafter "the Lottery") is coordinated by Confederation Centre of the Arts (official charity name: Fathers of Confederation Buildings Trust) as a fundraising activity to allow the pursuit of projects of benefit for citizens of Charlottetown, Prince Edward Island, and all of Canada as the country's national memorial to Confederation. Lottery proceeds will support youth programming and education in visual and performing arts; the development of new theatrical works; exhibition, programming and publications in the Art Gallery; and heritage programming.

By entering this Lottery the entrants and participants automatically agree to accept and abide by these official rules and regulations. All decisions of Confederation Centre of the Arts with respect to any aspect of this Lottery, including without limitation the eligibility of entries, are final and binding on all entrants in all matters as they relate to this Lottery.

TO ENTER: simply purchase an official ticket at a cost of \$100 (three for \$250) between Friday June 28, 2019 and Friday, September 27, 2019. Tickets may be purchased:

Lottery ticket sales start at 10:00 a.m. Atlantic Standard Time (AST) on Friday June 28, 2019 and close at approximately 10:00 p.m. AST on Saturday, September 27, 2019. There is one (1) grand prize to be won from all the eligible tickets purchased during the Lottery sale period.

A maximum of 500 tickets will be offered for sale, providing the chance to win one prize as outlined below. The odds of winning will depend upon the number of tickets sold and the total number of eligible entries purchased by each individual during the Lottery sale period.

#### THE PRIZE

The Lottery prize consists of: A trip for two consisting of a trip to Greece provided by Collette, and two return economy air tickets (not to exceed \$1,200 per ticket) from Charlottetown Airport provided by CAA Atlantic.

Total prize value is approximately \$15,000. Winner is not entitled to the difference, if any, between stated approximate value and actual retail value at the time the prize is awarded. Prize must be accepted as awarded unless otherwise specified. No cash surrender value.

Certificate valid for listed travel only. Certificate has no cash or refundable value. Travel is land for two only and subject to availability and all travel restrictions. 60 day advance notice required when booking. Valid for double occupancy only. Prize certificate is non-transferable/non-endorsable/non-refundable. Prize certificate will not be replaced if lost or stolen. Prize is valid for travel one year from date of issue. Certificate cannot be used for deposit. Certificate is for final payment only. Any changes to the reservation once booked are subject to change fees to be paid by the recipient.

Blackout dates and other limitations may apply. Subject to availability at time of booking.

Transportation to and from the airport, the obtaining of any necessary travel documents, gratuities, alcoholic beverages, insurance, additional activities and other stray incidentals not expressly described herein are the sole responsibility of the winner and his/her travelling companion.

Winner must provide CAA Atlantic with necessary information for each person travelling in your party in order to book your trip. Prize is transferable; but cannot be altered after booking without additional cost to the winner.

#### ELIGIBILITY

Tickets available for purchase to those 19 years of age or older, exclusively through Confederation Centre of the Arts. Tickets cannot be purchased in the name of a minor.

Tickets must be purchased and/or mailed within Prince Edward Island. Online and telephone purchasers must have a valid Prince Edward Island mailing address. Tickets are available for sale to non-residents of Prince Edward Island provided the purchase transaction takes place in person within the province of Prince Edward Island.

Employees of Confederation Centre of the Arts, Confederation Centre of the Arts Foundation, Collette, and CAA Atlantic are not eligible to purchase or hold a Lottery ticket, nor are their spouses and any related or dependent person residing in the same household.

#### **PURCHASING TICKETS**

Tickets will be offered for sale at the price of \$100 per ticket, or three tickets at the price of \$250 (one individual purchaser). A maximum of 500 tickets will be offered for sale, offering the change to win one prize as outlined. There is no limit to the number of tickets an individual may purchase.

The odds of winning will depend upon the number of tickets sold and the total number of eligible entries purchased by each individual during the Lottery sale period.

Payment must be received in full for ticket purchase to be valid. In the event of an invalid cheque or credit card transaction, the ticket issued will be considered invalid.

Only one method of payment will be accepted per transaction, only one mailing address will be recorded, and only one envelope will be issued or mailed containing all tickets.

Tickets may be purchased as gifts; purchaser must provide the correct legal name(s) at time of purchase. Please note that it is the responsibility of the ticket purchaser to allocate the gift ticket and potential prize.

Ticket purchases are neither refundable nor tax deductible. Prize is not transferable.

#### THE DRAW

Winners will be selected through a random draw from all eligible entries received during the Lottery sale period.

On Friday, September 27, 2019 during the final Friday night performance of Mamma Mia!, a random draw will take place on stage, at Confederation Centre of the Arts, 145 Richmond Street, Charlottetown, PE. Draw will be made by representatives from CAA Atlantic and Collette; at least two paid staff from Confederation Centre of the Arts and one member of the Board of Directors will be present.

The first entry drawn will be eligible to win the prize. Winning name and ticket number will be announced on stage live, then posted at confederationcentre.com and on social media immediately following the draw. The winner will be notified by Confederation Centre via telephone/e-mail within 24 hours of draw with instructions on how to claim the prize.

Prize must be claimed by replying to the prize notification, by contacting the Confederation Centre Box Office at 1-800-565-0278, emailing <u>info@confederationcentre.com</u>, or by presenting in person. Proof of identification must be provided upon request.

Before being awarded the prize, potential winner will be required to sign and return a full release and indemnity form stating that he/she has read and understood these official rules and regulations, grants all consents required, authorizes Confederation Centre, CAA Atlantic, and/or Collette to broadcast, publish and disseminate his/her name and/or photography, in connection with any promotion or publicity, and/or for general news, entertainment and information purposes at no additional compensation to the potential winner and/or travelling companion(s), beyond the awarding of or participation in the prize, accepts the prize as offered, and releases the Lottery sponsor(s) from any and all liability of any kind arising out of the potential winner's and/or travelling companion's participation in this Lottery and receipt and use of the prize.

If the prize remains unclaimed for 15 days following the draw, another draw shall be made.
